- 4. Working knowledge of the operation and preventive maintenance of equipment listed below
- 5. Working knowledge of grading techniques, trimming, planting and methods of fertilizing
- 6. Installation and upkeep of Bermuda grass fields
- 7. Skill in the use of hand and power tools related to gardening
- 8. Ability and willingness to follow oral and written directions
- 9. Ability to skillfully operate maintenance equipment
- 10. Ability to write reports as to time and materials used
- 11. Ability to read and comprehend the operator's manual for the various pieces of equipment
- 12. Ability to pick up and carry 50 pounds
- 13. Ability to work in a kneeling and/or crawling position and consistently bend, stoop, lift, reach above shoulders and stand for long periods of time.
- 14. Ability to be free of allergies to grass used by the school system
- 15. Ability to work in adverse weather conditions, climb ladders, and operate heavy duty equipment
- 16. Ability to interact with the general public as well as professional and classified employees of the school system in a pleasant and business-like manner
- 17. Knowledge of safe driving practices and proven safe driving habits by verification of driving records
- 18. Required criminal history background check and proof of U.S. citizenship or legal resident alien status

REPORTS TO: Buildings and Grounds Supervisor /Principal

JOB GOAL: This is semi-skilled manual work. An employee in this class, with general, technical and administrative supervision from an assigned supervisor, maintains playing fields, trees, shrubbery, lawns and other grounds of the Rumson School District.

PERFORMANCE RESPONSIBILITIES:

Essential job functions

- 1. Maintains lawns, playing fields, trees and other grounds for the school district.
- 2. Lifts, carries and applies grounds materials.
- 3. The employee is responsible for using safe practices and methods in the operation of equipment and supplies related to their job.
- 4. The employee is responsible for correcting and/or reporting any conditions within the building or grounds which may be hazardous to employees, students, or staff members assigned to the building
- 5. Performs other duties as assigned.

Examples of Work

- 1. Operates backhoe, tractors, edgers, sod cutters, dump trucks, various types of mowing equipment and hand tools.
- 2. Grades playing fields and other areas, seeds them, cuts sod, prunes trees and shrubbery
- 3. Prepares mulch and applies same around trees and shrubbery
- 4. Removes snow and ice from walkways and pathways

- 5. Haul stones and gravel from quarries to job sites
- 6. Cuts grass
- 7. Cleans tracks and parking lots
- 8. Assists in the transporting of small building material to other sites
- 9. Cleans and maintains equipment

- 11. Performs other duties as assigned.
