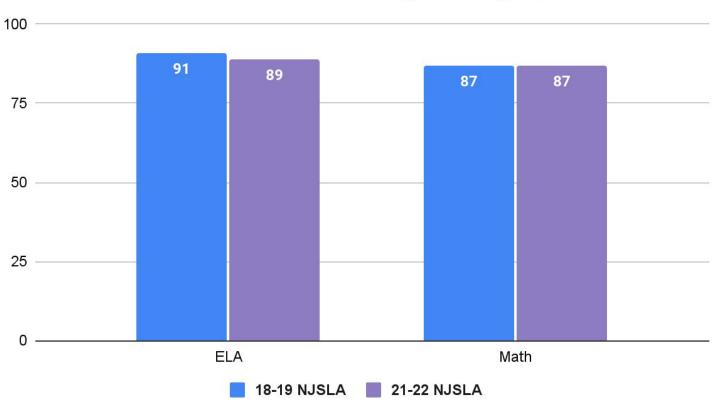
The 2023-2024 Budget supports the realization of student potential by...

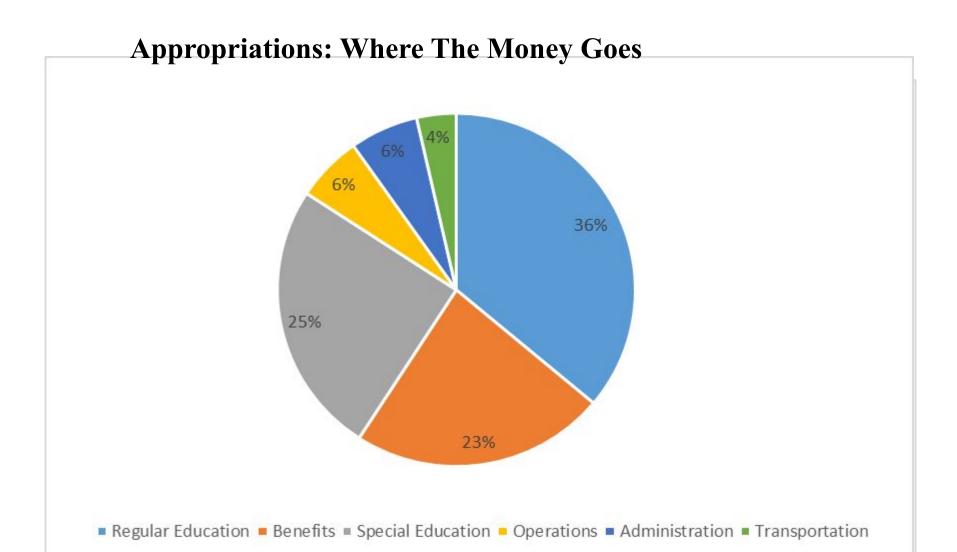

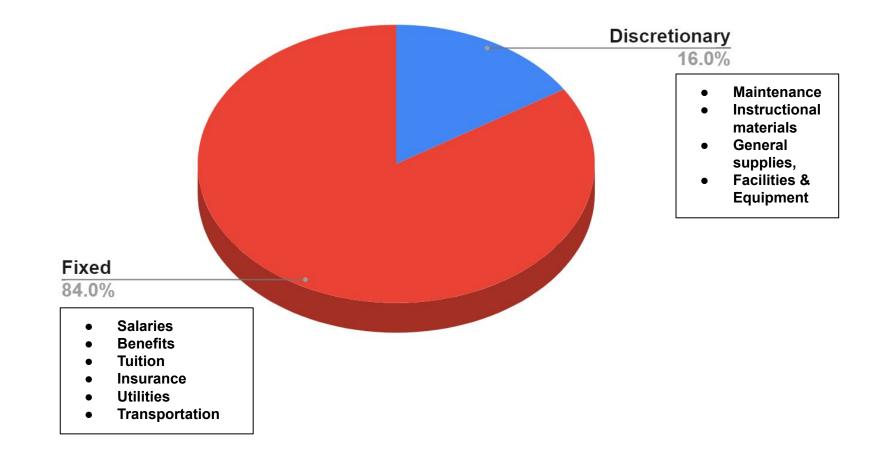

Discretionary vs. Fixed Expenses





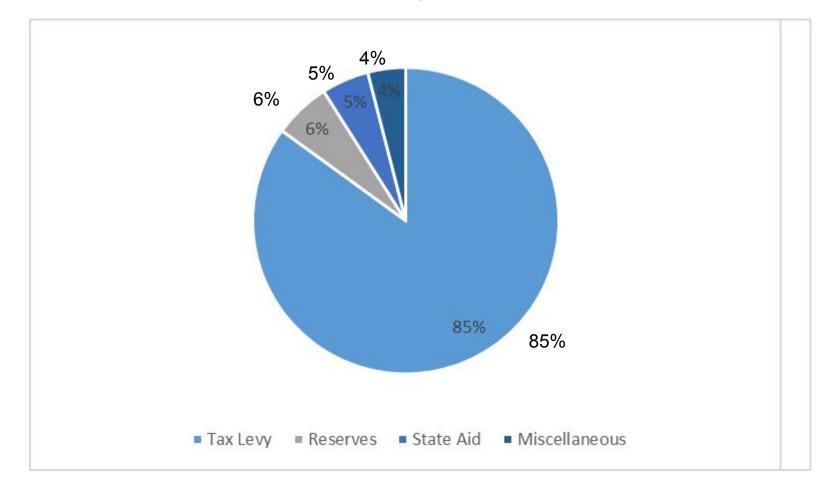
